**THE CADET CORPS (AMENDMENT) BILL, 2018**

**MEMORANDUM OF OBJECTS AND REASONS**

This Bill seeks to amend the Cadet Corps Law (2016 Revision) to remove the existing term limit for the position of Chairman of the Cadet Corps Committee. It also seeks to change the responsibility for the appointment of the Cadet Corps Committee from the Governor to the Cabinet.

- (b) by deleting the words “of the Committee shall be three years, except that the Chairman shall vacate his office at the end of three years from his appointment as Chairman.” and substituting the words “of each member of the Committee shall be up to three years and each member shall be eligible for reappointment.”.
