

## CABINET OF THE CAYMAN ISLANDS – POST MEETING SUMMARY

Her Excellency the Governor Mrs. Jane Owen, chaired the meeting of the Cabinet held on Tuesday, 5<sup>th</sup> March 2024 in the Cabinet Conference Room, Government Administration Building.
