### REMINDER TO FUEL IMPORTERS

The Utility Regulation and Competition Office (“the Office”) reminds all fuel importers of their obligations under Section 63(1) of the Dangerous Substances Regulations, 2017 which states:

“An importer of fuel shall, within forty-eight hours of notifying an operator of a change in the wholesale price of fuel, by notice in writing inform the Chief Fuels Inspector or an inspector authorised by him of the wholesale price at which the importer is selling an imperial gallon of fuel.”

A person who contravenes regulation 63 (1) commits an offence and is liable to an administrative penalty provided under the “Regulations”, i.e., Dangerous Substances Regulations (the “Regulations”).

All importers are urged to ensure compliance to avoid any enforcement action by the Office. For further information or guidance, please contact the Office.
