

## **NOTE 2**

All Cayman Islands Laws (cited as Acts since 3<sup>rd</sup> December, 2020) and Subsidiary Legislation which have been published as supplements to the Gazette since 2006 or supplements to the Extraordinary Gazette since 2008, may be perused on the Cayman Islands Government Official Gazette website - <http://www.gazettes.gov.ky>. Since February 2019, all Cayman Islands Laws/Acts and Subsidiary Legislation have been published as supplements to the Legislation Gazette and may be perused on the Cayman Islands Government Official Gazette website as well as at the Portfolio of Legal Affairs' legislation website – <https://Legislation.gov.ky>

## CONTENTS

The legislation listed in this Index is customarily set out in three Parts.

1. Part 1, at pages 7 to 43, consists of –

(a) Acts (cited as Laws prior to 3<sup>rd</sup> December, 2020) enacted by the Cayman Islands Parliament (termed as the Legislative Assembly prior to 3<sup>rd</sup> December, 2020 pursuant to UKSI 2020/1283) which are in force, partially in force or which have not yet been brought into force, and which Acts have not been consolidated or revised.

(b) Subsidiary legislation made by the Cabinet, or other authorised body, which is in force, partially in force or which has not yet been brought into force, and which subsidiary legislation has not been consolidated and revised.

(c) Consolidated and revised editions of Cayman Islands Acts and subsidiary legislation which have been published under the authority of the Law Revision Act (2020 Revision) and which have been neither repealed nor replaced by a subsequent revision.

2. Part 2, at page 44, consists of the Constitution of the Cayman Islands, Royal Instructions and various Statutory Instruments made by the Governor or other authorised body.

3. Part 3, at pages 45 to 75, consists of Statutory Instruments made in the United Kingdom under an Imperial Act or other United Kingdom Acts of Parliament, which may have been published in the Cayman Islands Official Gazette since 1974 or which have been referred to in Statutory Instruments so published and includes subsidiary legislation made by the Governor, Cabinet or Ministry under the authority of an Act or Statutory Instrument of the United Kingdom. In the interest of completeness, Statutory Instruments that have been revoked are also listed with the details of the Statutory Instrument giving rise to their revocation. Readers are advised that the compilation of Statutory Instruments is an ongoing process. The list provided herein has been compiled on the basis of analysis done to date.

## GUIDE TO REFERENCES

### **1. Acts/Laws (which have not been revised):**

These are referred to by their number and year of enactment and are indexed according to the number of the Gazette, the year of publication and the number assigned to the supplement containing the Act/Law — eg “LG3/2019 s3” means issued as supplement No. 3 with Legislation Gazette No. 3 of 2019.

The Citation of Acts of Parliament Act, 2020 (Act 56 of 2020), that commenced on 3rd December, 2020, provides that legislation previously enacted as ‘Laws’ by the Cayman Islands Legislative Assembly should be cited as ‘Acts’. However, in the interest of clarity and consistency, the original reference has not been changed. By way of example only legislation enacted prior to 3rd December, 2020 will be cited as the Adoption of Children Act, 2013 (Law 7 of 2013) while legislation enacted after 3rd December, 2020 will be cited as the Legal Services Act, 2020 (Act 57 of 2020).

It follows that legislation repealed prior to the commencement of the Citation of Acts of Parliament Act, 2020 (Act 56 of 2020) would not be within scope of this Act and would therefore continue to be cited as ‘Law’, given that any such Law would be a nullity as at that commencement date. Similarly, given the wider scope of ‘Law’ as provided by Section 2 of the Interpretation Act (1995 Revision), legislation enacted by the Governor, as set out in Part 2, continues to be cited as a ‘Law’.

### **2. Subsidiary Legislation (which has not been revised):**

These are referred to by their citation and by their ‘SL’ secondary legislation number (since August 2018). These are also indexed according to the number of the Gazette, the year of publication, the number assigned to the Supplement containing such subsidiary legislation or, where it does not appear as a Supplement to the Gazette, the page of the Gazette on which it is published. They are listed under the Act or revised Act under which they were made or by virtue of which they remain in force.

**3. Revised Acts/Laws and revised subsidiary legislation:**

These contain in their short title a calendar year that indicates the year in which the revision took place. In respect of Acts/Laws and subsidiary legislation which have been revised more than once, only the current revision is listed. The first page of each revision sets out the short title of the original Acts/Laws or subsidiary legislation and the number and year of the original Law/Act and of each amending enactment or the citation of the amending subsidiary legislation. Where such number or citation is followed by the word “(part)”, this indicates that the amending enactment contains other provisions not relevant to and not included in that particular revision. Since 2019, all revisions have also included a table of legislation history in the endnote which lists all the legislation that has been incorporated into that revision. Each revision is referred to in the same manner as laws and subsidiary legislation.

**4. Citation of dates:**

Where a date is given, reference is made to the day, month and year in that order — e.g. 10.05.97 means 10th May 1997.

**5. United Kingdom Acts of Parliament and United Kingdom Statutory**

**Instruments:** The UK Acts are referred to by a calendar year that indicates the year of enactment, followed in brackets by a chapter number which indicates the manner in which they are cited in the United Kingdom. United Kingdom Statutory Instruments are referred to by a calendar year followed by a number that indicates the year in which they were made and the reference number by which they are cited.

**6. Abbreviations:**

“C” means the chapter number of a United Kingdom Act of Parliament;

“G” means the Official Gazette of the Cayman Islands;

“GE” means an Extraordinary Gazette and is followed either by its number (from 1995 on) or by the date on which it was published (up to 1995);

“GN” means Government Notice;

“LG” means a Legislation Gazette and is followed by its number (from 2019 on);

“p” means a page of the Gazette;

“s” means a supplement to the Gazette;

“SL” means subsidiary legislation (from 2018 on); and

“UKSI” means United Kingdom Statutory Instrument.

7. All Acts/Laws are listed alphabetically in each Part, and immediately following each such Act/Law, the subsidiary legislation made under it is also listed alphabetically.
