GRAND CAYMAN - LIQUOR LICENCES PERMITTED HOURS

In accordance to Section 11.(3) of the Liquor Licensing Act (2019 Revision) the following shall be known as the permitted hours of Liquor Licences of Grand Cayman effective for all licences as of October 1, 2023.

The permitted hours published in this notice does not apply to Cayman Brac and Little Cayman premises/licences.

All premises under a retail licence, a hotel licence, a temporary licence, and a restaurant licensee shall comply with Section 11.(8) of the Liquor Licensing Law (2019 Revision) where states that all disposal of intoxicating liquor must cease during the ten (10) minutes of each period of permitted hour.

A licensee and licensed premises must operate in compliance with the Liquor Licensing Law (2019 Revision), Music And Dancing (Control) Act 2019 Revision, Music and Dancing (Control) (Amendment) Act, 2022 and all other relevant Acts.
