ROADS ACT (2005 REVISION) Section 6 Authorisation to Enter Lands

In exercise of the powers conferred on the Governor in Cabinet by Section 6 of the Roads Act (2005 Revision), and acting upon recommendation of the National Roads Authority and its agent District Administration Public Works Department, it is hereby declared that it is in the public interest to lay out and construct an access road as described hereunder:

REGISTRATION SECTION:	Cayman Brac East
REGISTRATION BLOCK:	106E
BOUNDARY PLAN:	BP 669
NATURE OF ROAD WORKS:	The proposed roadworks are defined by the boundaries outlined in green on BP 669 and listed in the Schedule below.

1. The National Roads Authority and its agent are authorised to enter upon lands listed in the Schedule below for the purposes of road works as publicly declared as intended under Section 3 The Roads Act (2005 Revision);
2. Such authority will take effect 15 days from the date of publication of this Notice in the Cayman Islands Gazette;
3. The line and anticipated boundaries of the road works are shown edged green on Boundary Plan 669.
